

RECEIVERS PURSUANT TO  
IDAHO BAR COMMISSION RULE  
519.

ADMINISTRATIVE ORDER  
19-09

RE: JOHN BRADLEY

Pursuant to Idaho Bar Commission Rule 519, Eric J. Wildman, Administrative District Judge of the Fifth Judicial District, finds that;

WHEREAS, following an illness and brief disability, attorney John A. Bradley passed away, on September 30, 2019, and having received proper proof of the fact;

WHEREAS, an order pursuant to Idaho Bar Commission Rule 517 was not entered prior to Mr. Bradley's untimely passing;

WHEREAS, Mr. Bradley was a sole practitioner with no partner or responsible party, it has become necessary to appoint lawyers to protect the interests of Mr. Bradley's clients.

BEING FULLY ADVISED IN THE PREMISES, IT IS HEREBY ORDERED:

1. That Lawyers Elizabeth Burr-Jones and Brett Anthon are appointed as attorney receivers to inventory the current client matter files of John Bradley and to take such action as seems indicated to them to protect the interests of Mr. Bradley and his clients;
2. That consistent with I.B.C.R. 519(b), the confidentiality protection of Idaho Rule of Professional Conduct 1.6 shall be extended so that the review of any files by Ms. Burr-Jones and Mr. Anthon is not deemed to be a disclosure to a third party;
3. This Order operates as an injunction prohibiting all financial institutions holding all trust and operating accounts of Mr. Bradley from disbursing moneys on the signature of John Bradley or at his direction;
4. Bar Counsel, Ms. Burr-Jones, or Mr. Anthon shall serve a copy of this Order of Appointment of Attorney Receiver on all financial institutions holding the trust and operating accounts of Mr. Bradley, including all accounts for which Mr. Bradley is principal or trustee. Service of this Order of Appointment of Attorney Receiver on a financial institution shall permit Ms. Burr-Jones or Mr. Anthon to substitute their authority for that held previously by Mr. Bradley in all respects with regard to such accounts;
5. After inventorying the current client matter files of Mr. Bradley, Ms. Burr-Jones and/or Mr. Anthon shall notify each client of his or her right to attain any papers or other property to which he or she is entitled and the times and places at which the papers or other property may be obtained, calling attention to any urgency for action on the client's part;
6. Ms. Burr-Jones or Mr. Anthon may release to each client, upon request and the signing of the proper releases, the papers and other property to which the client is entitled;

7. Ms. Burr-Jones and Mr. Anthon may place any fee-generating work with other lawyers consistent with I.B.C.R. 519(g);

8. Within 90 days after appointment, Ms. Burr-Jones and Mr. Anthon shall file a final report with the Idaho Supreme Court, the undersigned Administrative Judge and Bar Counsel, including their request for release from the Order of Appointment of Attorney Receivers and for disposition of any and all files that remain in control and custody of Ms. Burr-Jones or Mr. Anthon;

9. Any costs incurred by Ms. Burr-Jones or Mr. Anthon for the work done under I.B.C.R. 519 or this Order shall be paid from fees owing to Mr. Bradley or by the Idaho State Bar;


10. In administering this Order, it is intended that as a general rule, fee-generating work that can be placed by Ms. Burr-Jones or Mr. Anthon with private practitioners for handling under reasonable and customary arrangements for remuneration will be so placed and will not be retained by Ms. Burr-Jones or Mr. Anthon, and any exception thereto shall be approved by the Administrative Judge; and

11. I.B.C.R. 519 and this Order shall not be applied to force representation upon any objecting client.

IT IS FURTHER ORDERED that the appointed Attorney Receivers shall further comply with all guidelines as described in Rule 519.

IT IS HEREBY ORDERED.
