WHEREAS, the District Court of the Fifth Judicial District of the State of Idaho, in and for the County of Twin Falls, charged by the Constitution of the State of Idaho for the administration and supervision of the judicial system, and acting in its inherent powers in controlling actions and conduct before the court and insuring the safety of said premises and records, all court personnel and members of judiciary therein, all persons lawfully entering and using said public courtrooms, and all litigants and their counsel in matters coming before the court, does hereby enter this order to provide for the management and security of the offices and the orderly conduct of all proceedings therein.

NOW, THEREFORE, IT IS HEREBY ORDERED that all persons entering the Theron W. Ward Judicial Building are hereby prohibited from carrying or having readily accessible to them at

any place inside the Theron W. Ward Judicial Building any firearms, dangerous weapons, explosives, or incendiary devices, without prior approval of the court security officers.

IT IS FURTHER ORDERED that all persons entering or being in the Theron W. Ward Judicial Building and all courtrooms used by the District Courts and Magistrate Courts of the Fifth Judicial District are hereby prohibited from uttering loud, threatening or abusive language or otherwise engaging in any disorderly or disruptive conduct, at any place within said courtrooms.

IT IS FURTHER ORDERED that upon disclosure of this order to any such person committing any of the proscribed acts, unless such person immediately ceases and desists from committing the proscribed acts and complies with any order or direction of any peace officer, judicial officer, or employee of the court, in furtherance of this order, that such persons shall be subject to the contempt powers of the court and may be required to show cause why they should not be held in contempt of court and sanctioned therefor.

IT IS FURTHER ORDERED that a copy of this order shall be posted at a conspicuous place in the Theron W. Ward Judicial Building to provide notice to all parties entering said courtrooms.

IT IS FURTHER ORDERED that any peace officer observing a person acting in conflict to this order is hereby instructed and ordered to take such person into custody and at the appointed

time bring them before the court, or a justice thereof, to make determination of whether there has been an action in contempt of this court.

POLICY FOR IMPLEMENTATION OF THE ADMINISTRATIVE ORDER
OF THE MATTER OF THE MANAGEMENT, SECURITY AND CONDUCT
OF PERSON ENTERING INTO THE THERON W. WARD JUDICIAL
BUILDING.

Peace officers.


Under the terms of the above administrative order, all federal, state and local peace officers are prohibited from carrying firearms into the Theron W. Ward Judicial Building without prior approval of the court security officers. To implement this policy, weapons lock boxes will be available so that officers coming into the courthouse may check their weapons to be kept safe by court security personnel.


It is anticipated that there will be situations where court security personnel will need to enlist the assistance of peace officers in providing security for the courthouse. In those situations, court security officers are authorized to allow peace officers to carry weapons into the Theron W. Ward Judicial Building.

A security desk with sufficient lock boxes will be installed in the main lobby of the Theron W. Ward Judicial Building to be manned during all business hours. Until such time as the security desk is in place, peace officers with weapons are asked to check them in the sheriff's office in the old courthouse.


We appreciate the input provided by law enforcement personnel in the formulation of these policies and procedures and thank you for your continued cooperation.
