21-18

WHEREAS, this court has previously assigned coverage judges for treatment courts in the Fifth Judicial District as outlined in Amended Administrative Order 17-01, dated September 28, 2017, and March 18, 2020, and

WHEREAS new Magistrate and District Judges have recently been appointed to the bench requiring an update to the coverage assignments, and,

WHEREAS new Treatment Courts have recently been developed, and,

WHEREAS certain judges are assigned to preside over treatment courts in the Fifth Judicial District and,

WHEREAS those assigned judges occasionally have other court duties and cannot attend their respective treatment courts,

IT IS HEREBY ORDERED that the following schedule of priority for coverage shall apply and the alternate judges listed in this schedule can preside over the respective treatment courts in the absence of any of the assigned presiding treatment court judges.

IT IS FURTHER ORDERED that the following listed Magistrate and District Judges are authorized to preside on an interim basis over certain felony criminal cases that are transferred to and accepted into a Felony Treatment Court:


